- The customer has ultimate responsibility for the final decision regarding the size of dress ordered. Please contact your bride or Signature Bridal Salon, LLC for the appropriate size chart. A size may be recommended by a consultant based on the measurements provided by the customer, but the size entered on this form is what will ultimately be ordered.

Terms and Conditions

Orders and Delivery

- Dresses are custom ordered. Orders cannot be placed until Signature Bridal Salon, LLC receives all signed documentation and all applicable payments for all members of the bridal party. It is the responsibility of the customer to allow sufficient time for placing orders, receipt of garments at the store, and shipping (if necessary).
- Rush charges may apply to orders placed less than 16 weeks before the wedding date. Rush fees and lead time vary according to Designer so please contact our store for designer-specific information.

Shipping

- Customers may pick up orders at our store free of charge. Shipping from the salon to the customer will be at the customer's expense and will be made via UPS with both insurance and a signature for delivery required. This policy is non-negotiable. The customer must notify Signature Bridal Salon, LLC in writing at least 48 hours before desired shipment. The customer assumes all responsibility for merchandise once it leaves Signature Bridal Salon, LLC.

Return Policy

- **ALL SALES FINAL.** All sales are final and cannot be exchanged or returned. Changes to processed orders can NOT be made. Signature Bridal Salon, LLC requires payment in full prior to removing any merchandise from the store and before any alterations are made. THERE ARE NO EXCEPTIONS.

Payments

- A deposit of at least 50% of the total balance is required at the time the order is placed. A final payment of the remaining balance is due within 30 days of initial purchase.
- All payments are subject to non-negotiable, recurring \$35 late fee per every 30 days of no payment, unless payment arrangements have been made.
- All merchandise is to remain under the ownership of the store until the balance is paid in full.
- Payments may be made via phone or online. To make payments online visit www.signaturebridalsalon.com/payment.
- If payment is 60 days late, deposits paid are lost and ownership reverts to Signature Bridal Salon, LLC. If paid merchandise is left unclaimed in store 10 days past date of event on file, all monies paid are forfeited and ownership reverts back to Signature Bridal Salon, LLC.
